Statement of intent

Muntham House School is committed to using the Bursary Grant for the 2023-24 academic year to enhance the educational attainment of our disadvantaged pupils. The grant will be utilized to eliminate financial barriers to education, ensuring equitable access to essential educational resources, travel, and community activities. We aim to provide targeted support to address individual student needs, thereby fostering an inclusive and supportive learning environment.

Challenges

Challenge number	Detail of challenge
1	Access to Course-Specific Equipment: Many students lack essential tools, overalls, laptops, and software necessary for their specific courses.
2	Travel Costs: Financial constraints prevent students from affording transportation to and from school, leading to absenteeism and disengagement.
3	Participation in Community Activities: Limited financial resources hinder students' ability to participate in beneficial community activities such as gym memberships and educational excursions.
4	Additional Learning Resources: Students often require additional learning materials which are not covered by standard school provisions
5	Emergency Financial Support: Unforeseen financial difficulties can impact students' ability to continue their education without support.

Intended outcomes

Enhanced student participation in community activities	Success will be evaluated based on the number of students participating in funded community activities.

- **Intended Outcome:** Reduction in absenteeism due to travel-related financial issues.

- **Intended Outcome:** Increased student participation in physical and educational community activities.

Bursary Grant strategy outcomes

- **Impact:** Distributed overalls, tools, laptops, and software to 100% of eligible students.
- **Outcome:** Enhanced student participation and performance in practical courses.

Travel Support:

- **Impact:** Provided bus passes and railcards to all P16 students that attended other provision.
- **Outcome:** 100% of pupils passed their College Courses.

Community Activities:

- **Impact:** Funded gym memberships and educational excursions for all P16 students.
- **Outcome:** Increased student engagement in physical activities and educational outings, fostering holistic development. Including Siler DofE accreditation, Climbing Snowdon and Complete Outward Bounds Trust Certification.

Additional Learning Resources:

- **Impact:** Supplied additional learning materials to P16 students such as online courses, instruments and additional software for Game Design, Music and Esports.
- **Outcome:** Improved academic performance and better preparation for exams.

Emergency Financial Support:

- **Impact:** Provided emergency funds to students facing sudden financial hardships allowing continued access to College Provision.
- **Outcome:** Ensured continued education without financial disruption for those students.
